HGVs may need to go to **Manston Airport**.

- Go to **Stop 24**, alternatively **Sevington** or **Ashford International Truck Stop**.

#### *Import through the Port of Dover*

- Go to **Dover Western Docks**, alternatively **Sevington** or **Ashford**.

- The Port of Holyhead cannot process ATA Carnets - go to **Roadking Truckstop, Holyhead**
- Open Monday to Sunday: 7am to 10pm. You must enter the ATA Carnet processing area no later than 9:45pm.

Border controls are being introduced in stages:

- From January 2021: basic customs requirements, such as keeping sufficient records of imported goods, and will have up to six months to complete customs declarations.
- From April 2021: All products of animal origin and all regulated plants and plant products will also require pre-notification and the relevant health documentation.
- From July 2021: Traders will have to make declarations at importation and pay tariffs.

- The EU's data adequacy assessment of the UK is underway. If the UK is assessed as adequate by the end of the transition period, the free flow of personal data can continue.
- If the EU has not made an adequacy decision by that time, you should act to ensure you can lawfully receive personal data from EU/EEA businesses and others in the future.
